Course outcome

101C-1: History of India (Pre-historic time to 600 BC)

CO1: After completing the course the students are expected to understand the basic foundation of pre-historic India.

CO2: After completing the course the students can get a clear idea about Indian physical geography and antiquity of our civilization. It also denotes the values, tradition of our ancestry.

CO3: Students will explore and understand the historical development of ancient India.

102C-2: History of Classical Greece.

CO1: Students will develop a crucial understanding of major traditions and ideas in the field of Ancient Greece.

CO2: After completing the course the students will be able to understand the classical period of world civilization is reflected in the history of Greece and historical development of the democracy in early civilisation of Greece. Apart from polity, philosophy, art and architecture, drama, even games and sports of ancient Greece and its subsequent evolutions the moral of this course.

201C-3: History of India (600 B.C. to 650 A.D.)

CO1: After completing the course students will develop a sound understanding of major traditions and ideas in the field of History of India (600 B.C. to 650 A.D.).

CO2: After completing the course students will develop their understanding about the major areas of ancient Indian history - (a) emergence of India as a political power, i.e. state formation in Ancient Indian. (b) The spirit of Indian culture.

201C-4: Medieval World (Fall of the Roman Empire, Medieval Europe, Coming of Islam)

CO1: Students will understand and apply concepts of Medieval World.

CO2: Students will be able to understand the economic developments in Europe from 7th century to 14th century.

CO3: After completing the course students will develop a basic understanding of Religion & culture of Medieval Europe.

CO4: The students are expected to understand the basic nature of the medieval Arab society and coming of Islam and its impact on world trade and economic system during that time.

301C-5: Early Medieval India (650 A.D. – 1206 A.D.)

CO1: After completing the course students will have a basic knowledge of historical geography of ancient India.

CO2: After completing the course students will know the early existence of self government of the *Chola* tradition.

CO3: Students will know about the history of Bengal during this time and the emergence of other regional power in the political scenario of post-Gupta period.

CO4: Students will know what character of the Indian feudalism was and process of the fragmentation of the imperial power and how it was took place the coming of Islamic Power in the Indian subcontinent.

302C-6: Transformation of Europe

CO1: From this curriculum students will be able to gather ideas on two major areas of European history— (a) Social, cultural as well as religious transformation of Europe, (b) Political and economic transformation of Europe from the time of decline of feudalism to 17th century.

CO2: Students will be able to understand the early nature of capitalism.

303C-7: History of Medieval India (c.1206-1526 A.D.)

CO1: After completing this course curriculum on the medieval Sultanate period of Indian history students will have a clear knowledge about the history of Sultanate from its establishment, consolidation to its disintegration and fall.

CO2: Students will also be able to gather ideas on different regional powers and the socioeconomic and cultural aspects during the period from 1206 A.D. to 1526 A.D.

401C-8: History of Europe (c.1789 A.D. to c.1870 A.D.)

CO1: Upon completion the course the students will know the different aspects of French Revolution-1789.

CO2: Students will know the major political events up to Balkan Nationalism during this time.

CO3: Students will be able to find the correlation between imperialism and industrial transformation during the time in different European states.

402C-9: History of Medieval India (c.1526 A.D. to c.1756 A.D.)

COL Students will know the literary sources on this historical time.

CO2: It will provide a clear idea to the students about the history of *Mughal Empire* from its establishment, consolidation to its disintegration.

CO3: Students will also gather knowledge on different regional powers and the administrative, socio-economic and cultural aspects during the period from 1526 A.D. to 1756 A.D.

403C-10: History of India (1757 A.D. to 1885 A.D.)

CO1: Students will have better familiarity with different aspects of Modern India. They will understand the idea of 'modernity', and, historiography and discourse on this terminology.

CO2: Students will know all about the emergence of regional powers after the downfall of Mughals.

CO3: Students will know about the British Company's territorial expansion in India and its administration, economic and social policies,

CO4: Finally, Students will have a better understanding about the effects and response to colonial rule.

501C-11: History of Modern Europe (c. 1870 to c. 1991)

CO1: Upon completion the course students will have a sound knowledge on the major themes in Europe and global history during 20th century.

CO2: Students will be able to understand the Europeanised world in the aftermath of the First World War and coming of a multi-polar world of the new millennium.

CO3: Students will know the major international events of the century- World War I; the totalitarian state of Nazi Germany & Stalinist Russia; World War II; Cold War between super powers; de-colonization in Asia & Africa & the foundation of U.N.O.

CO4: The students will have a sound familiarity with the major ideologies of the century (liberalism, republicanism, fascism, communism and post 1989 neo-liberalism) and the global and imperial reconfiguration of the world power.

502C-12: History of India (1885 to 1947)

CO1: After completing the course the students will know those events and movements which had been played an active role to decolonising this subcontinent, i.e., Rowlatt Satyagraha, Non-cooperation movements, Civil disobedience movement, and tribal-peasant movements etc during this time.

CO2: Students will know those ideological foundations behind the decolonisation, i.e., *Gandhian* thoughts, leftist thought etc.

CO3. After completing this course students will know how colonialism has had a deep impact on the sub-continent and that various sections in the region continue to grapple with its legacies.

CO4: Students will know the historiography of modern Indian history, including nationalist, imperialists, Marxists and post-colonial perspectives.

601C-13: History of India (1947 - 1992)

CO1: After completing this course students will know some important aspects of a complex, highly diverse India that is also witnessing unprecedented changes since its independence in 1947 from Britain.

CO2: students will have a clear understanding about the foundation of new course of the postcolonial democracy.

CO3: They will have knowledge about the social dimensions of change in postcolonial India, political democracy, economic transition from state to market, gender, caste, India's economic and political globalization and changing world view.

602C-14: History of South-West Bengal (1740-1947

CO1: After completing this course student who belong to this region, will have a historical knowledge about their own region (south-west Bengal), focus on the status of South-West Bengal in *Mughal subah* of Bengal; establishment of British rule in South-West Bengal; agrarian structure in colonial times and agrarian revolts; socio-cultural and religious life; western impact on education; nationalist politics and role played by the locals in freedom struggle

CO2: They will feel the importance of regional history.

304 SEC-1: Archives and Museum

CO1: From this paper a student will have a basic idea about the Museums, i.e. excavation, field exploration, collection, preservation etc.

CO2: Students will be able to understand the traditional past clearly through the artefacts preserved in the museum.

CO3: Students will be able to know how the pasts documents would be handled methodologically preserved in the Archives.

405 SEC-2: Understanding Popular Culture
